#### 8.2 Exposure controls

#### Appropriate engineering controls

Handle in accordance with good industrial hygiene and safety practice. Suitable personal protective equipment (PPE) should be worn prior to use. Wash hands before breaks and at the end of work day.

#### Eye and face protection

Avoid contact with eyes. Always use protective safety glasses with side-shields conforming to EN 166 (EU).

#### **Skin protection**

Avoid contact with skin and mucous membranes. Avoid prolonged or repeated contact with skin. Always use disposable chemical-resistant gloves conforming to EN 374 (EU) to handle the product. Gloves must be inspected prior to use and should consist of materials such as latex, butyl rubber, ethyl vinyl alcohol laminate (EVAL), neoprene, nitrile/butadiene rubber ("nitrile"/NBR) or polyvinyl chloride ("vinyl"/PVC). When prolonged or frequently repeated contact is expected, gloves with protection class 6 (breakthrough time > 480 min according to EN 374) are recommended. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended. The selection of a specific glove type should also take into account all relevant factors, such as but not limited to: other chemicals that may be handled; physical requirements such as puncture protection, dexterity and thermal protection; potential allergic reactions to glove material; and additional instructions and specifications from the glove manufacturer. If gloves are damaged during use, immediately remove and replace. Use proper glove removal technique, ensuring that the outside of the glove does not come into contact with bare skin. #### **Body Protection**

#### **Respiratory protection**
