Appropriate engineering controls

Eye and face protection

Avoid contact with eyes. Always use protective safety glasses with side-shields conforming to EN 166 (EU).

Skin protection

Gloves must be inspected prior to use and should consist of materials such as latex, butyl rubber, ethyl vinyl alcohol laminate (EVAL), neoprene, nitrile/butadiene rubber ("nitrile"/NBR) or polyvinyl chloride ("vinyl"/PVC). When prolonged or frequently repeated contact is expected, gloves with protection class 6 (breakthrough time > 480 min according to EN 374) are recommended. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended.
