Appropriate engineering controls

When prolonged or frequently repeated contact is expected, gloves with protection class 6 (breakthrough time > 480 min according to EN 374) are recommended. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended. The selection of a specific glove type should also take into account all relevant factors, such as but not limited to: other chemicals that may be handled; physical requirements such as puncture protection, dexterity and thermal protection; potential allergic reactions to glove material; and additional instructions and specifications from the glove manufacturer. Body Protection
