### 8.2 Exposure controls

#### Appropriate engineering controls

Handle in accordance with good industrial hygiene and safety practice. Suitable personal protective equipment (PPE) should be worn prior to use. Wash hands before breaks and at the end of work day.

#### Eye and face protection

Avoid contact with eyes. Always use protective safety glasses with side-shields conforming to EN 166 (EU).

When prolonged or frequently repeated contact is expected, gloves with protection class 6 (breakthrough time > 480 min according to EN 374) are recommended. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended. The selection of a specific glove type should also take into account all relevant factors, such as but not limited to: other chemicals that may be handled; physical requirements such as puncture protection, dexterity and thermal protection; potential allergic reactions to glove material; and additional instructions and specifications from the glove manufacturer.
