Skin protection

Gloves must be inspected prior to use and should consist of materials such as latex, butyl rubber, ethyl vinyl alcohol laminate (EVAL), neoprene, nitrile/butadiene rubber ("nitrile"/NBR) or polyvinyl chloride ("vinyl"/PVC). When prolonged or frequently repeated contact is expected, gloves with protection class 6 (breakthrough time > 480 min according to EN 374) are recommended. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended. The selection of a specific glove type should also take into account all relevant factors, such as but not limited to: other chemicals that may be handled; physical requirements such as puncture protection, dexterity and thermal protection; potential allergic reactions to glove material; and additional instructions and specifications from the glove manufacturer.
