Appropriate engineering controls

Handle in accordance with good industrial hygiene and safety practice. Suitable personal protective equipment (PPE) should be worn prior to use. Wash hands before breaks and at the end of work day.

When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended. Body Protection
